What is this Privacy Policy for?

This privacy policy is for this website agigrass.com and served by Artificial Grass International LTD and governs the privacy of its users who choose to use it.

The policy sets out the different areas where user privacy is concerned and outlines the obligations & requirements of the users, the website and website owners. Furthermore, the way this website processes, stores and protects user data and information will also be detailed within this policy.

The Website

Use of Cookies
